

Finance

The financial position of the Trust remains strong thanks to the generous support of our many benefactors and careful investment of funds.



The greatest investment following our staff and guests, are the facilities.

Regular maintenance and upgrading continues to ensure a high standard is maintained and the homely character of Ozanam House is maintained.

Operating costs of \$462,745, an increase compared to last year \$404,607 attributable to increased operating costs and gratis accommodation.

Costs as always are under constant scrutiny to ensure efficiency is maintained and donations are put to good use.

Operating revenue increased by \$53,306 reflecting higher occupancy.

Unsolicited income in this year was \$200,764 / LY \$541,253, the decrease attributable to a large bequest last year.

Investment income of \$267,993 / LY \$247,106, an increase of \$20,887 compared to the previous year. The Trust investments showed a capital increase of \$474,836 on the previous year. Prudent investments have continued to provide a source of income, enabling the Trust to maintain and enhance its assets and to provide capability for future expansion of our facilities and services as and when needed.

The effectiveness of the Trust activities are not all measured by a financial value.

The Trust is experiencing increased demand from carers and family of inpatients and together with changes in procedures of Health Boards more one night accommodation is being requested.


Not all accommodation costs of patients and carers are recovered. As a Charitable Trust, it's important we contribute in small ways to the wellbeing of inpatients and their carers. We have adopted a compassionate policy towards those requesting accommodation with each case judged on its merits. In the past year over 755 bed nights of non-subsidised accommodation were provided to patients and carers, compared to LY 526.

Although patients will always take priority for accommodation, depending on occupancy and extenuating circumstances whenever possible extra carers and family are cater for.

Our accountants, Coombe Smith, have supported our administration, answered many queries and offered advice. We wish to acknowledge their support and advice.

Our auditor Darryl Pinny has carried out his duties in a timely manner and has tendered good advice. I thank him for his efficiency and will be recommending his re-appointment.





General

This year The Trust celebrated 50 years of providing a "home away from home". The Trust hosted an open day and a celebration dinner with many of those associated over the years present. A book written by William Muirhead, "A Home Away from Home Like No Other" was published outlining the 50 year history of the Trust and the personalities involved from its humble beginning in 1967. The book has been distributed to libraries in the central region and those associated with the Trust.

The Trust hosted the annual guests Melbourne Cup day and Christmas party which was enjoyed by all. The Trust once again financially supported the Cancer Society to hold a successful Relay for Life.

Long serving housekeeper Nancy Tawharu retired after serving for over 21 years and will be remembered for upholding the special homely character for which Ozanam House is renowned for. We welcomed Sharleen Dahlberg as her replacement.

I would like to make a special mention of our administration and housekeeping staff who in addition to their normal duties carry out many behind the scenes initiatives to enhance guest wellbeing. It is gratifying to repeatedly receive comments of appreciation from patients which is testimony to the spirit of compassion and understanding shown by our staff.

There are many challenges the Trust faces in adapting to a changing landscape in treatment procedures and methods as well as continuing to provide services to patients within the defines of our Trust deed.

My two year term as chairman ends this year and I would like to thanks my fellow Trustees Bill Bly, Terry Comber and Peter Noble-Campbell for their support and wise counsel and look forward to serving the interest of the Trust in the future.
