# OZANAM HOUSE TRUST CHAIRMAN'S ANNUAL REPORT 2011

A momentous, perhaps history making, year. Certainly one which makes it worthwhile to take a minute to record and subsequently consider.

First, I should record that that the Trust has completed its 40<sup>th</sup> year and, secondly, 2011 was my first and last as the Trust Chairman. I should explain.

The position of being Chairman to the Trust is legislated to change each two years and rotate between the Representatives of the Trustees. The Society of St Vincent de Paul nominated me to replace Bill Bly at our last Annual General Meeting.

At that meeting, also, we accepted the retirement of Cliff Craven, a Trustee for over 20 years, and Dr Bernard Forde, whose 10 years' contribution was of high quality and gratefully received by the Trust. While Bernard's health gave rise for concern more recently, I am pleased to be able to say he is still an interested attendee at functions of any of the many organisations he gave his voluntary time to.

Unfortunately, I have to report that shortly after Cliff Craven's retirement, and there having been a suitable function to acknowledge his contribution, his health took an unexpected and serious turn, resulting in his death on 10 November 2010. He predeceased his wife, Noeline, by only a matter of months. R.I.P.

As is the good fortune of this organisation, we have been fortunate in the calibre of the replacements nominated by each of the Trustees.

Mr Peter Noble-Campbell, with a farming background and a resident outside the immediate vicinity, was nominated by the Cancer Society of which he is an extremely active member. He has an interest in men's health and has shown already a deep empathy with the plight of the cancer patients and their families.

The Society, of which I am a member, nominated the present Chairman of their group to follow some illustrious footsteps. Terry Comber, JP, has also a lifetime of experience in legal practices, bringing a wealth of knowledge from that area, in addition to the lessons learned from serving many organisations within the city over many years.

The Trust Board was pleased to welcome these two new members. Anybody with a knowledge of the history of the Trust would appreciate that replacements of Trustees representatives is not a common occurrence.

It occurs to me to set out in the record hereunder the names and dates of those who have served the Trust since its inception. The list, as you will see, includes the remaining initial Board member since the inception of the Trust in 1972. More about him later.

At all times he has borne in mind the welfare of the guest as of paramount importance, guided by the spirit and philosophy of the St. Vincent de Paul Society. It was only earlier this year when he faced the prospect of a change in family lifestyle that he considered retirement.

We wish him all the best for the future.

As I had shown considerable interest in the workings of the Trust and its administration, Tony approached me with the approval and knowledge of my fellow Board members, to enquire if I would be interested in assuming a more hands on role. There were two things he said:

- 1. it was not hard work, and
- 2. an empathy with the principles of the Trust was of paramount importance in dealing with its administration.

I asked for time to consider the request and, one second later, agreed I would be honoured to accept.

From a background in the agricultural servicing sector, I look forward to my role in the non-profit domain and, together with the support of Trustees and staff, in continuing the successful service which the Trust provides. I wish to carry on the spirit and objectives of the Trust, and the principles of the Society of St. Vincent de Paul, in providing care for patients and caregivers in a "home away from home" environment.

I would also like to thank my fellow trustees and loyal staff, who continue to be the face of the Trust in their daily contact with our guests.

It is always humbling to read the many favourable comments from our guests who echo not only the practical application of what we do, but the manner in which we operate.

The working of the Trust continues as previously, building on those foundations. Our relationships continue to sustain us and assist in our management.

A more mundane aspect being the addition to and the upkeep of our buildings, and this was assisted by association once again with the Lions Clubs of the two districts covering the area we serve. As a result, on the occasion of the Annual General Meeting at which this report will be presented, we proceed to officially open a Recreation Room "Frimley/Springhill Foundation Room" and the office block at St. Mary's containing a Games Area known in future "The Lion's Den". Our gratitude to the Lions for this valued initiative has been acknowledged here and during the course of the opening ceremony.

**2010** 9-19 days 6-21 days The downward trend of room nights occupied from 2005 appears to be tracking down. The variation between nights occupied and reimbursed indicates those nights the patient returns home, but the room is kept for them. This indicates that patients live in their rooms 67% of the time that they occupy them.

## **FINANCE**

The financial position of the Trust remains strong. Despite economic downturns donor generosity continues and our investments have rewarded us well. Our unsolicited donor income in this year was \$433,398 / LY \$390,266.

The year in review shows more fully the effect of rising costs on the Health Department's contribution by way of the accommodation subsidy. The Board takes any opportunity to remind our funders that, like everyone else, we face increased costs.

Our operating revenue at \$1,031,374 / LY \$1,099,279 reflects a slight downturn in nights accommodation during the year. Costs are constantly in need of surveillance and this is a regular topic between administration and our accountants.

Overheads, including Depreciation of \$334,181 / LY \$186,084, were at \$1,233,987 / LY \$917,832. Circumstances of accommodation requirements change from year to year and last year we reduced the use of outside facilities, namely motels. We were able to recover only a portion of that cost.

Investment income at \$113,644 / LY \$114,812 reflects, in my view, a reasonable return bearing in mind:

- a) a reduction in rates of interest, and
- b) rising costs inhibiting our ability to reinvest.

While our investments show an increase of \$618,069, on the previous year our fixed assets (i.e. land and buildings) increased by \$173,654 without any revaluation adjustment.

Our auditor, Darryl Pinny, has accorded us his usual courtesy and carried out his duties with little, if any, interruption in the Trusts' administration. I thank him for his efficiency and interest. His re-appointment I will be recommending to the Board.

### GENERAL

The ongoing maintenance and refurbishment of the facilities will continue to enhance the homely character of Ozanam House. This is made possible with the assistance and support of our many contributors.

A challenge facing the Trust at present is the decision pending by Tairawhiti Health to move patient care to Waikato. Gisborne and East Coast guests account for around 14% of total guests. We know from the positive feedback received from guests from East Coast that the homely atmosphere we provide and the ability to stay at weekends is a feature that we offer at Ozanam House which is second to none. We trust that the patient welfare takes precedence in the Health Board's decision.

As I move into the role of Secretary, I would like to thank my fellow Trustees and the retiring Secretary for their support and also our loyal staff, who continue to be the face of the Trust in their daily contact with the care of our guests.
